

Highlights Progress since June 2004 Report

Programs and Priorities Providing national leadership in higher education, and promoting leadership development

Academic Leadership Program (ALP)

Established in 1987, the Academic Leadership Program develops the leadership and managerial skills of faculty on CIC campuses who have demonstrated exceptional ability and administrative promise. The 2004-05 Academic Year marks the 16th year of the ALP, with seminars hosted by the University of Iowa (October), the University of Illinois at Chicago (February) and the University of Minnesota (April). The recently held Seminar at Iowa included 51 Fellows as well as campus ALP Liaisons and guest speakers focusing on topics related to leadership and human resources, including both President Skorton and Provost Hogan. The second Seminar will be held February 3-5, 2005 at UIC.

Benchmarking Public Engagement for Research Universities

In spring 2003, the CIC Committee on Engagement and the Council on Extension, Continuing Education, and Public Service (CECEPS) of the National Association of State Universities and Land-Grant Colleges (NASULGC) agreed to work together to generate benchmarks that all universities can use to assess institutional effectiveness and service to society. Together, the CIC and NASULGC committees agreed upon a series of benchmarks and measures which will allow universities to assess fulfillment of their engagement/public service missions, as well as a serve as a basis for gathering economic development and technology information and building support for higher education among legislators, donors, and the public. Such measures also provide departments with criteria for including scholarly engagement activities for faculty and instructional academic staff as part of the tenure and promotion processes. The committee has prepared a report for the CIC Members entitled "Resource Guide and Recommendations for Defining and Benchmarking Engagement." The report will be available on the CIC web site after the December 8 meeting of the CIC Members.

Department Executive Officers (DEO) Program

DEO develops leadership opportunities for department heads and chairs (Department Executive Officers). Institutional team participants for the semiannual seminar include seasoned veterans as well as newer department heads and chairs. The 2005 DEO Seminar for department heads and chairs will be held March 31 – April 2, 2005, at the Big Ten Conference Headquarters in Chicago. The DEO Liaisons will be attending a planning session in mid-December to prepare for the Seminar. Participating institutions typically send 4 or 5 participants each to the Seminar.

National LambdaRail Membership

CIC Chief Information Officers in 2003 purchased a seat on the board of National LambdaRail, Inc., a national optical fiber networking collaboration whose members consist of leading U.S. research universities and private sector technology companies. Phase 1 implementation was completed in August 2004 and connected the following locations: San Diego, CA; Los Angeles, CA; Sunnyvale, CA; Portland, OR; Seattle, WA; Denver, CO; Chicago, IL; Pittsburgh, PA; Washington, DC; Raleigh, NC; Atlanta, GA. Phase 2 implementation, slated for completion in Spring 2005, will extend the NLR infrastructure across the country to Louisiana, Texas, Oklahoma, New Mexico, Arizona, Salt Lake City and New York.

Scholarly Communication Summit

On October 28, 2004, the CIC Members (Chief Academic Officers) convened a meeting to discuss and act upon issues related to the scholarly communication system that supports journal literature. Forty-five attendees, from the faculty, libraries, presses, administration and the disciplines were invited to participate in the summit. Through a series of conversations, attendees developed a vision of a future in which many partners in the academy work together to support communities of digital scholarship that serve faculty and scholars, are housed by the universities, designed for the disciplines, and encompass the best services provided by the commercial publishers without the crippling economic models currently in use. In close cooperation with the faculty, the CIC intends to test this premise by launching a multi-faceted effort to move the system of scholarly communication closer to these ideals. If endorsed by the CIC Members, the effort would include both the development of a pilot, inter-institutional digital repository with a subject focus; and the development of a communications effort to work with faculty to inform them of their intellectual property rights and the benefits of participating in efforts such as open access initiatives. The final report from the summit will be available on the CIC website after the December 8 meeting of the CIC Members.

Strengthening the collective capacity of CIC institutions by combining, leveraging and expanding resources

Virtual Electronic Library

The CIC Virtual Electronic Library (VEL) is a Web-based interface into the public access catalogs of all the CIC member libraries. Since July 2000, over 650,000 library items have been shared among CIC institutions.

Consortial Purchasing and Licensing


- ♦ The CIC Purchasing Consortium held its annual meeting October 5th at the University of Iowa. Principal topics of discussion included the renewal of the CICPC contract for services with E&I Cooperative; policies and procedures for renewal of existing commodity contracts when they expire; policies for extending individual campus vendor contracts to other CIC universities; and planning for a meeting during the spring of 2005. The next annual meeting of the CICPC will be held during the fall of 2005 at Northwestern University.
- ♦ Since January 2004, CICPC has spent in excess of \$16 million on combined purchases of office supplies, scientific supplies, A/V tapes, anti-virus software, networking equipment, and background check services. Within the next few weeks the CICPC will undertake its first-ever "reverse auction" (most likely for copy paper purchases). The process involves establishing a "maximum" acceptable bid amount for volume purchasing of a commodity, with suppliers being able to place competing bids on-line in a live auction in an effort to get their bids down to this acceptable limit.
- CIC's collaborative library licensing realized approximately \$1.3 million in cost avoidance through consortial license and purchase agreements from March 2004 through October 2004. More than \$21 million in cost avoidance has been realized since the program began. Currently there are 28 license or purchase agreements encompassing 68 different products.

HireBig10Plus

HireBig10Plus is a consortium of career centers of the CIC universities and the University of Notre Dame. In August the group held a planning session to prepare for activities for the 2004-05 academic year. Projects this year will include a spring job fair hosted by the University of Chicago Career Center, a "Diversity on LaSalle Street" session to acquaint minority undergraduates with financial career opportunities and internships with financial firms in downtown Chicago, and a continuation of the online job placement services with Monster.com.

Expanding Information Technology Infrastructure

Alliances for Expanded Study in Overseas Programs (AESOP) and Study Abroad Programs

AESOP is a cooperative program designed to match unused study abroad capacities with the unmet study abroad needs of other CIC institutions. Currently there are over 60 programs based in 29 countries and spread across six continents. The program pool periodically changes; many of these programs are niche programs with small enrollments which make them excellent prospects for the AESOP pool.

The CIC AESOP Coordinators and the CIC staff have been working along with their Study Abroad Financial/Administrative Systems Colleagues to streamline and brainstorm easier mechanisms related to the administrative and financial processes related to AESOP. These processes can be complex and as different as each CIC university. The creation of a Web-based program database was implemented this summer. To make editing of program files quick and easy for all AESOP Coordinators, a revised cosponsorship matrix has been designed and is in use, with a web-based version available by January 2005.

The three CIC summer programs in Quebec City, Canada; the Dominican Republic; and Guanajuato, Mexico, once again showed strong summer application numbers.

- The Dominican Republic program received 26 summer applications and had 19 participants.
 The Fall semester program received 13 applications and has 13 students currently in the program. Five students participated in both the summer and fall programs. Dr. Christine Tisone, Indiana University PhD, was the new Resident Director for Summer 2004.
- The Mexico program had 55 students this summer. The new Resident Director for Summer 2005 will be Assistant Professor Antonio Tillis from Purdue University. A small contingency from the CIC, including Dr. Tillis, visited this summer's program in Guanajuato.
- The Quebec summer program received approximately 30 applications and 26 attended. The fall semester has two students. Professor Julie Auger, Indiana University, a Quebecoise, was the new Resident Director for Summer 2004.

American Indian Studies Consortium

The CIC AIS Consortium, begun in 2001, draws upon the Newberry Library's matchless collections and the CIC's vast institutional resources to facilitate the training and development of graduate students in anthropology, history, literature and other fields whose academic research focuses on Native American culture and experience.

Since June 2004, the American Indian Studies Consortium has hosted several events, including the CIC Fall Graduate Student Workshop, held in conjunction with the CIC National Conference, "Native Peoples and Museums: Building Reciprocal Relationships for the Twenty-First Century." Graduate students and faculty from each of the CIC institutions had the opportunity to speak with scholars from world-renowned museums, community centers, and universities. Preparations for the spring Workshop are underway, as are plans for the sixth annual CIC AISC National Conference, CourseShare, and a recruitment brochure.

Foreign Language Enhancement Program (FLEP)

Each year, the CIC Liberal Arts and Sciences Deans sponsor scholarships valued at \$2,000 to help graduate students take advantage of language offerings not available at their home university, but available at another CIC campus. For Summer 2004, 45 students applied to the Foreign Language Enhancement Program (FLEP), a 25% increase over 2003. This increased interest may be attributed to the increased promotion by the CIC office and the CIC Foreign Language Liaisons. Additionally, a FLEP marketing poster and bookmark were created last fall along with an email HTML bookmark, which increased outreach efforts on all campuses. This summer, 22 FLEP awards were made available, with 5 alternates. Previously, 24 awards were offered. Twenty awardees officially accepted, but only 19 were able to use their FLEP award. These 20 students are from nine CIC institutions and will be studying an array of less commonly taught languages including Arabic, Azeri, Sanskrit, Tagalog and Vietnamese at five CIC host institutions.

Traveling Scholar

The Traveling Scholar Program enables doctoral-level students at any CIC university to take advantage of educational opportunities – specialized courses, unique library collections, unusual laboratories – at any other CIC university without change in registration or increase in tuition. Since the program began in 1963, more than 5,300 doctoral students have made use of this program. In 2003-04, 237 students from 14 CIC campuses traveled to 11 CIC campuses. Additionally, the CIC Traveling Scholar liaisons re-ratified the program's eligibility policy and voted to keep the program for doctoral student travel only.

CourseShare

CIC CourseShare is an administrative process and support system that allows CIC faculty to offer and share (on a voluntary basis) unique and specialized courses to other CIC universities, and supports the necessary administrative infrastructure for course approval, registration, etc.

Currently, less commonly taught languages (LCTLs) are being taught using CourseShare, including Uzbek and Kazakh from Indiana University to select participating CIC campuses. Also, American Indian Studies faculty will use CourseShare to offer a Spring 2005 seminar to select CIC campuses.

Other recent interest in the inter-institutional sharing of select courses has come from engineering and chem-informatics. Less Commonly Taught Languages (LCTLs)

In October 2003, the CIC LAS Deans charged the CIC LCTL Working Group 2004 with increasing access to less commonly taught languages by identifying 3-5 less commonly taught languages to be shared within the CIC. By March 2004, The Working Group had consulted with their campus colleagues and made their submissions to the CIC. From this language proposal process, 56 different languages were identified as of interest to share within the CIC. This Working Group has now considered this list as well as taking into consideration the needs and strengths of individual campuses, formats, levels and opportunities proposed. The Group submitted a proposal to the CIC LAS Deans in November 2004 identifying languages to be offered and suggesting how these languages might be delivered inter-institutionally. Various CIC programs may be used to assist with increasing access: CIC CourseShare, Traveling Scholar, AESOP and FLEP programs.

Expanding learning opportunities, cont.

Diversity Forum

The CIC Diversity Forum is a biennial conference that explores issues of diversity on CIC campuses. The 2005 CIC Diversity Forum will be hosted by Purdue University on April 3-5, 2005. Under the theme, "From the Baccalaureate to the Professoriate," the conference will promote critical examination of diversity practices and climate issues throughout the student pipeline. The conference program is being constructed and more information will be available soon. TechForum

TechForum is a biennial conference sponsored by the CIC CIOs for their IT staff members who don't typically attend other national IT conferences. The TechForum 2005 Planning Committee has been formed by the CIC CIOs and has begun to plan for the Sept 13-14, 2005 conference to be hosted by the University of Minnesota.

FreeApp Program

The CIC Graduate Application Fee Waiver (FreeApp) allows applicants to request a fee waiver for graduate applications to PhD or Master of Fine Arts programs at CIC institutions. FreeApp has been a valuable resource to prospective students of CIC graduate programs. Over the course of the 2003-04 academic year, the CIC received 906 applications for the CIC FreeApp. Students applying to MFA and PhD programs at a CIC institution are encouraged to take advantage of this opportunity.

Summer Research Opportunities Program (SROP)

The Summer Research Opportunities Program (SROP) is a program to interest talented undergraduate minority students in academic careers and to enhance their preparation for graduate study through intensive research experiences with faculty mentors. SROP opened its 2005 application cycle on November 1. Planning is underway for the 2005 CIC SROP Conference. The University of Wisconsin-Madison will host the conference on July 15-17, 2005, and this year's theme is "Networking for Scholarly Achievement." Directory of Minority Students

The CIC publishes an online directory of minority students in an effort to increase the professional opportunities for minority graduate students and to aid colleges, universities and other potential employers in the recruitment of highly educated underrepresented minorities. The CIC Minority Access Panel is currently reviewing the purpose and strategies for enhancing the Minority Directory. Key concerns are increasing the numbers of eligible candidates and graduates who register and promoting use of the Directory among CIC institutions. Strengthening Recruitment and Retention of Underrepresented Students Across the CIC

The Minority Access Panel is developing new strategies for cooperative recruitment of underrepresented students to CIC graduate programs. Strategies will reflect the diversity of recruitment practices that member institutions employ and will draw on flexible and dynamic relationships with SROP alumni and liaisons at targeted institutions. The plan is based on recommendations for cooperation recruitment outlined in a Spring 2004 report to the CIC Graduate Deans. Universities would provide money to underwrite their professors' books

PUBLISH OR PERISH is the timeworn mantra in the humanities and social sciences. Yet what happens to this ironclad rule of scholarly life when the publishers of academic research themselves begin to perish?

The 90 institutions of higher education that have their own academic presses now bear all the costs of a system used by most if not all universities.

And many of those presses are under increasing pressure from their parent institutions to break even. The presses at the University of Idabo and Northeastern University, for example, have announced that they would shut down. Many other presses face deep cuts.

Philip M. Pochoda, director of the University of Michigan Press, is among those asking when and how institutions without presses will "pay their fair share for this whole network that is supporting and unsergirding their tenure and promision."



Mission

The CIC is a consortium of twelve universities committed to advancing academic excellence by sharing resources and promoting and coordinating collaborative activities.

Vision

Through a series of dynamic and evolving collaborations, our universities will continuously increase access to educational and research opportunities; share resources; and address issues critical to the future of the research university.

Operating Principles

The CIC is, literally, the Provosts of the member universities who serve as the Committee, and to whom the CIC staff report.

New and emerging initiatives of the CIC are developed in two ways:

- The Provosts identify issues to be addressed and direct the CIC staff to implement and coordinate activities or programs in response. These issues are dynamic and arise through focused conversation at the semiannual meetings of the Provosts.
- 2. The CIC headquarters staff raise issues with the Provosts and the various committees, facilitate sharing and vetting of these issues and ideas, and then follow through on the decisions of the Provosts and others to pursue strategies arising through these broad discussions.

Additionally, the CIC staff coordinate two important functions, in addition to facilitating discussion and action as described above:

- 3. The CIC headquarters staff operate, evaluate, and manage a set of core programs, approved by the Provosts, with a focus on programs that cannot be easily coordinated by the member universities individually.
- 4. The CIC staff support and coordinate peer group discussions and meetings as resources permit. Staff focus efforts on those groups convened at the specific request of the Provosts. Generally speaking, peer groups are self-organizing and operating, though the CIC staff assist with meeting arrangements and email lists, and offer guidance as needed.

hrough their affiliation in the CIC, the member universities strive to promote academic excellence through voluntary cooperative endeavors that unite and leverage institutional resources (human, financial, and infrastructure), and that provide a forum for the exchange of information and ideas, and the sharing and implementation of practical solutions to common problems.

The primary focus is on specific activities where it is clear that economies of scale and influence can be realized through working together. These opportunities are neither constrained nor dictated by trends in higher education, generally. Rather, areas of focus are identified by the Provosts of the member universities who work with the CIC staff to consider and direct opportunities:

- Providing national leadership in higher education, and promoting leadership development
- Strengthening the collective capacity of CIC institutions by combining, leveraging and expanding resources
- Expanding learning opportunities by sharing unique courses and programs, and by supporting access to hose traditionally underrepresented in the academy.




